Regardless of the care taken, it is impossible to guarantee that participants will not experience an injury or adverse experience at Sunbeam Nature School.

I also understand that I should have health and accident insurance to cover injuries arising from participation in nature school programs. I also understand that I am responsible for the immediate pickup of my child upon completion of the program.
